I, the undersigned, do hereby acknowledge that:

I have read and understood the Corporate Membership Agreement & the Terms and Conditions overleaf, as well as the Indemnities and Rules and Regulations of SWAT.

I agree to be bound by these documents and other documents in force from time to time.

I, the undersigned instructor, hereby declare that I will be responsible for tactical training & safety of groups assigned to me or brought by me, and these groups will likewise be responsible to adhere to range rules, duties & responsibilities as set out by law.

I will enforce the establishment's safety regulations upon my students, and they too will be bound by the indemnity of the establishment, by signing my own indemnity, which includes the SWAT indemnity.

I acknowledge that this is not a 'once off' product. This is an automatically annually renewable contract, which will only be cancelled by the procedure as set out overleaf. I agree to pay the annual subscriptions, as described in the agreement overleaf.

I hereby agree to sign the official range register, indemnity and safety rules declaration as displayed at the range office each and every time I enter the range. This register will be conclusive proof of my expenditure for accounting purposes.

**Agreement Between SWAT and Company:**

**Company Account and Instructor Subscription**

**Terms and Conditions**

1. I warrant that I am duly authorized to enter into this agreement on behalf of the above company. I instruct and authorize SWAT to issue invoices which will be paid as described in the application form.
2. I will be entitled to utilize and access the SWAT Shooting & Training facilities from the **start date**, subject to the payment of the appropriate annual fees and signature of this agreement.
3. I am entitled to a document of a **Memorandum of Agreement** for aiding my applications for SETA Accreditations, with my valid and paid up membership. I understand that this certificate may not be used for any other purposes unless requested and authorized in writing.
4. I consent to my membership status being revealed and divulged at the Central Firearms Registry for Licensing and Accreditation purposes, as required by law.
5. This agreement is for a fixed period of one year (**Initial Period**) calculated from the start date. This agreement will commence from the start date, and will continue for the initial period and will thereafter automatically indefinitely renew for a fixed period(s) of 1 (one) year. Renewal Period(s).
6. To cancel my corporate account & Instructor subscription(s) a **termination notice** must be handed in to SWAT.
7. It is the payer's responsibility to ensure that the termination notice is received by SWAT, not less than 1 (one) clear calendar month's notice prior to the last day of the initial period or the renewal period(s), as the case may be.
8. I, the undersigned, do hereby acknowledge that I cannot cancel this agreement prior to the expiry of the initial period.
9. I will hand in all cards, and that of those on the company's membership, together with my termination notice, and pay all outstanding fees. If this is not done, my cancellation will not be valid, and fees for current registrations will continue as if I had not terminated my registration(s).
10. All arrear training invoices must be paid in full before the termination is valid.
11. I will be liable to pay cancellation invoices for subsequent yearly payments, or for cancellation, in advance, unless a termination notice is handed in to SWAT timeously.
12. I have familiarized myself with the Range rules and regulations in force from time to time and agree to be bound thereby.
13. I warrant that the instructors included in this membership are physically and mentally fit to handle firearms
14. I acknowledge that I have read and understood the **indemnity and waiver** as displayed at the range office and that SWAT will not be responsible for any injury or loss, including loss of life, suffered by me, my corporate group, the instructors included in this membership, and my staff, whether through any negligence and /or omission on the part of SWAT and /or any employee of SWAT, or for any reason whatsoever.
15. I warrant that the instructors included in this membership are legally competent and fulfill all requisites to handle, and instruct in firearms and other combatant arts, as the South African law prescribes.
16. I warrant that the instructors in this agreement have all the necessary licenses for all the firearms used on the SWAT's facilities, as issued by the Central Firearms Registry, and I am not in any way contravening the Firearms Control Act 60, of 2000.
17. I warrant that the instructors in this agreement have the necessary training to handle the firearms above, and such proof is lodged at the Central Firearms Registry. All instructors are aware of the tolerances, loads, distances & angles, and any other such technical data pertaining to the firearm and its use that is licensed to my company's name.
18. In addition, the instructors in this agreement have the necessary training and registrations to instruct third parties in the use of firearms.
19. The instructors on included in this membership will only use the tactical facilities, ranges and equipment, according to my abilities and skills. I will not attempt to engage in any activity in which I am not specifically trained. Such training is not included in my membership.
20. I warrant that my Corporate Group and the instructors included in this membership have all necessary accreditations and affiliations as prescribed by law, necessary for the operations of the type of training carried out at the SWAT premises.
21. I agree to keep all such accreditations and affiliations up to date, to such an extent that they will not endanger the position of the SWAT as far as its own affiliations and accreditations, and licenses to operate.
22. I warrant that the students being taught by the instructors included in this membership, are fully able to enter into training given, in terms of South African Law, and have no legal, physical, or mental impediments to do so.
23. I declare that to my fullest knowledge the students being taught by the instructors included in this membership are engaging such training for bona fide end purposes, and have no illegal intent.
24. In the event of my being an instructor, instructing on my own I hereby consent to the instructors students being bound to the terms of this agreement, and to the indemnity and waiver and rules of the range as displayed at the range office, and I indemnify SWAT and/or

- any employee of SWAT to the extent, if any, to which such student is not capable of waiving his/ her rights as contained herein, or where it is not practicable to do so.
25. Membership fees, shall be payable by members and shall be fixed for the Initial period and shall be paid annually in advance, and / or such other payment mechanism as may be agreed to in writing by SWAT or as deemed necessary by SWAT.
26. I will pay all monthly invoices, in favour of SWAT, at a bank account nominated upon the relevant invoice.
27. Invoices with respect to staff or students training on the premises will be issued monthly and must be paid within 30 days of date of issue.
28. A signature of any of one of the instructors on this membership on the appropriate **Corporate Register** shall be valid proof of training, and liable to payment, at the agreed rate per person.
29. Should the Company Account and /or Instructor subscriptions not be up to date, the agreed rate per person, shall become the full casual daily rate, as charged to members of the public. as they are then not entitled to special rates and the instructor shall also pay the casual daily rate, as they are then not entitled to free entrance.
30. The company shall be responsible for notifying SWAT if an instructor leaves the employ of the company and shall be liable for that instructor's invoice(s) unless a termination notice is handed in, in respect of that instructor.
31. The membership fees payable in terms of this agreement shall be fixed for the Initial period. SWAT may, after the initial Period, increase the membership fees each calendar year with such amounts as the Company in its sole and absolute discretion deems appropriate.
32. The Company may require members to also pay for the usage of services and facilities in the club specified from time to time by the Company in accordance with tariff fees which shall be made available to members at all times.
33. The full outstanding balance, if any, will become due and payable if I fail to pay any installment on the due date thereof, in which event I will become liable to pay all costs in connection with the collection of any amounts due by me in terms hereof including legal costs, inclusive of collections, commissions and courts.
34. I shall be liable to pay interest at the prevailing prime rate as charged by Standard Bank from time to time on any amounts due and payable in terms hereof and which is not paid on the due date. Interest shall be calculated from due date until the date of receipt of payment by SWAT.
35. SWAT may transmit details to credit bureaus of how I have performed in meeting my obligations in terms of this agreement and in the event that I fail to meet my obligations may record my non-performance with the applicable credit bureaus. I agree to be bound by the terms and conditions of this agreement mutatis mutandis
36. Access to SWAT facilities may be denied until such time as SWAT has received payment in full of the arrears invoice(s) plus interest accrued thereon and legal costs on the scale as attorney and own client, inclusive of collection , if any.
37. I hereby consent that SWAT may carry out a credit inquiry to open this account.
38. All notices and processes may be validly delivered or served upon me at my residential address as aforementioned, which I hereby choose as my Domicilium Citandi et Executandi for purposes hereof.
39. In the event that my bank details and/ or contact details change, I will update the information by means of the **Change of Details** form, which can be found at SWAT reception.
40. The Company reserves the right to forthwith cancel this agreement if I breach any of the Terms and Conditions of this Agreement inclusive of the Safety Rules and Regulations in force from time to time.
41. In the event of one or more of these terms, conditions, rules or regulations being unenforceable-same will be deemed to be severable from the remainder of the agreement.
42. If the home club ceases to operate, then my membership shall be terminated and I shall have no rights or claims against the Company save for a refund of a pro-rata amount of prepaid membership fees, if any, calculated at the casual rate.
43. I will be liable, however, to pay for all outstanding amounts for any and all training received, without any setoffs or refunds for unused memberships or parts thereof.
44. This agreement was duly and fully completed before the signatory by me and the information contained herein is true and correct. The Company reserves the right to cancel this agreement if the information supplied is found to be incorrect / and /or false.
45. This agreement contains all the terms and conditions of our agreement and no representation addition, variation or cancellation of this agreement shall be of any force and effect unless reduced to writing and signed by all parties.
